501C3 STATUS, REPORT

- After getting 501C3 status in 2021, we filed with the IRS in Spring 2022, 2023, 2024, and 2025, using Chuck Ham, an accountant in Texas. The filing must be done by an electronic provider, so our officers were unable to complete this task. Tracy Hoffman continues to submit a Franchise Tax form, required by all non-profits in Texas. Kirsten and Tracy both have access to the Chase bank account. After filing taxes with Chuck Ham, Tracy handed over a brief 2023 financial report to Kirsten. She has the 2024 report to hand over to Kirsten next she sees her.
- The IRS challenged our 2023 filing by sending numerous letters that we were one day late, requiring a \$20ish fee. The accountant at first advised us not to pay, but in the end, we decided it best to pay the fee, even though the IRS was wrong. Instead of spending endless hours on the phone with the IRS, our accountant opted to give us a free tax filing for 2024, as we paid the \$20ish fee plus all the mailing back and forth. Again, Kirsten Stine and Tracy Hoffman have the exact amounts on paper, and it was also filed with our 501C3 taxes in late April.
